


I. The September 24, 2015 project manager meeting (PMM) minutes were submitted to the Administrative Record (AR). There was no PMM held in October 2015. A PMM was scheduled November 4, 2015, to be followed by a tour of WESF. The PMM did not occur, but the tour did take place. The December 10, 2015 PMM minutes were approved by RL, and will be provided to the Ecology representative for WESF, who was not present today, for approval after today's meeting.

II. Operational Status

Dave Watson (CHPRC) provided the operational status for the WESF activities (see handout). Mr. Watson reported that the shielded storage device was moved back into G Cell, and there was some maintenance done on the device. The shielded storage device is being hooked up to utilities such as instrument air and compressed air systems, and testing will be done to ensure that it's operational.

Mr. Watson noted that a revised closure plan that was submitted to Ecology is in support of the stabilization/ventilation upgrade project activities.

Mr. Watson stated that early construction activities are continuing after approval was received from the Washington State Department of Health (WDOH). John Temple (Ecology) inquired about meeting with RL/CHPRC to discuss the temporary authorization (TA) request that was submitted. Stephanie Johansen (CHPRC) responded that an email was received from Mandy Jones (Ecology) about setting up a meeting to discuss the TA.

III. Status of Previous Agreements and Commitments

A. There were no previous agreements or commitments to status.

IV. New Agreements and Commitments

A. There were no new agreements or commitments identified.

V. Near Term Schedules and Ongoing Activities (Milestones, TSD Unit)

A. WESF Closure Plan

Rick Engelmann (CHPRC) stated that the closure plan was discussed under operational status.

B. Hanford Facility RCRA Permit Rev. 9 Update

Ms. Johansen stated that Ecology met with RL, ORP and the contractors on Tuesday (1/26/16) to discuss the deficiencies in the Part A, and the parties worked about halfway through the list. Mr. Engelmann noted that it was not just the Part A for WESF. Ms. Johansen responded that it was a general discussion regarding the Part A's, and there was no discussion about a specific Part A.

- VI. Approved Changes Signed Off in Accordance with TPA Section 12.2
 - A. There were no change requests identified.

- VII. General Discussion
 - A. Ms. Johansen referred to a discussion during the December 10, 2015, PMM regarding the capsule extended storage project, and that she had indicated RL/CHPRC would be ready to start discussing the schedule in January 2016. Ms. Johansen stated that she anticipated it would be at least March 2016 before RL/CHPRC are ready to discuss the schedule for the permitting portions of the storage project.

 - A. The December 10, 2015, PMM minutes were identified for submittal to the AR.

STABILIZATION / VENTILATION UPGRADE PROJECT ACTIVITIES

- Set up of temporary mobile trailers with utilities for construction work forces has been completed and the work force has taken occupancy.
- Removed portions of a deactivated steam line to WESF to make room for construction activities.
- Excavations for the new K3N ventilation skid and associated utility lines are in progress.
- Modifications and cleaning to the ventilation skid for use with Project W130 is in progress. Modifications include adding a second fan and motor, replacement of an electrical control panel and wiring, etc.
- The K3N heater used in heating the inlet air stream coming to the ventilation skid for treatment, has been fabricated and tested, and has been received.
