HPLC/IC

Method 300.0: The matrix spike (MS) recoveries for analytical batch 300-1317 were outside control limits for Sulfate and Nitrate as N. Sample matrix interference is suspected because the associated laboratory control sample (LCS) recovery was within acceptance limits. Samples in batch 1316 required filtration to reduce matrix interference and solids. Per the SOP both the Method Blank (MB 300-1317/5) and LCS (LCS 300-1317/6) were also filtered.

No additional analytical or quality issues were noted, other than those described above or in the Definitions/Glossary page.


