COMPLETION OF HANFORD FEDERAL FACILITY AGREEMENT AND CONSENT
ORDER (TRI-PARTY AGREEMENT) MILESTONE M-085-02

This letter documents the completion of Tri-Party Agreement Milestone M-085-02 "Submit a change package to establish a schedule for submittal of the Remedial Investigation/Feasibility Study (RI/FS) Work Plans for the 200-CB-1, 200-CP-1, and 200-CR-1 Operable Units and a schedule for submittal of the Removal Action Work Plans (RAWPs) for 224-B and 224-T Plutonium Concentration Facilities."

The Tentative Agreement signed on October 26, 2015, (attached) includes Tri-Party Agreement Change Control Form M-85-15-02. This change request includes Tri-Party Agreement Milestones M-085-70, M-085-80, and M-085-90 to submit RI/FS work plans for 200-CB-1, 200-CP-1, and 200-CR-1 Operable Units, and Tri-Party Agreement Milestones M-085-72 and M-085-100 to submit RAWPs for 224-B and 224-T Plutonium Concentration Facilities.
