Deactivation: Utility isolations were completed on the facility prior to demolition.

Decontamination and Decommissioning: Hazardous materials were removed prior to demolition and included Freon, oils, grease, lights, and mercury thermostat switches. The mobile office contained no asbestos building materials.

The mobile office was detached from utility services and transported to ERDF intact on June 26, 2014, and subsequently demolished in the landfill.

### Building History:

#### 1.0 FACILITY IDENTIFICATION

The MO-474 Building was a triple-wide transportable structure in the 100BC Area. Typical mobile office construction consisted of sheet metal and wood walls and roof on a steel frame. The MO-474 Trailer was located approximately 270 m (885 ft) northwest of the 105-B Reactor Building and served as the primary field office for Bechtel Hanford Incorporated and Washington Closure Hanford in the 100BC Area.


No waste sites present.
