

- I. The March 28, 2013, Project Managers Meeting (PMM) minutes were approved. The April 25, 2013, PMM was canceled.
- II. Operational Status
 - A. Linda Petersen (CHPRC) noted that the operational status was a summary for March and April 2013. Ms. Petersen stated that a campaign was just started in Basin 42, and once the level is down in Basin 42, the plan is to start a campaign in Basin 44. Ms. Petersen noted that the level is low in Basin 43.

- III. Status of Previous Agreements and Commitments
 - A. There were no previous agreements or commitments to status.
- IV. New Agreements and Commitments
 - A. There were no new agreements or commitments identified for discussion.
- V. Near Term Schedules and Ongoing Activities (Milestones, TSD Unit)
 - A. ETF Powder
 - Rick Engelmann (CHPRC) stated that the standard Land Disposal Restrictions (LDR) treatment will be applied to future ETF powder. Mike Collins (RL) added that efforts are still under way with the Environmental Restoration Disposal Facility (ERDF) to determine the exact treatment procedure. Al Farabee (RL) asked if a path forward has been identified. Mr. Collins responded that the path forward has been identified for treatment. Stephanie Johansen (CHPRC) indicated that this agenda topic could be removed.

B. ST4500 and 4502 Status

Rick Bond (Ecology) reported that a meeting was held yesterday with Cliff Clark (RL) to discuss the public comment regarding the 2 million gallons per day discharge limit in the ST-4511 permit. Mr. Bond stated that Ecology has proposed to reduce the daily discharge limit, and Mr. Clark requested that Ecology send RL a letter requesting a lower discharge limit with justifications. Mr. Bond indicated that the number may be lowered to 500,000 gallons, which is more than has been needed since 2006. Mr. Farabee noted that the largest amount in that time period was 300,000 gallons. Mr. Bond added that the usual discharge amounts are between 15,000 to 30,000 gallons per day, and the discharge can be done over a period of two days.

Mr. Bond stated that the ST-4500 permit has been delayed and will be started back up after July 1, 2013, which is the start of the fiscal year. Mr. Bond noted that funding has run out this fiscal year for the ST-4500 permit. Mr. Bond stated that revisions have already been done to the permit, and it shouldn't take long to get the permit out for public comment.

Ms. Petersen stated that there is an exemption in the ST-4511 permit for small leaks from pumps and valves, and similar language is being prepared for an exemption request to ST-4502. Ms. Petersen noted that discussion with Mr. Bond had been held previously regarding the exemption request, and that most of the leaks are associated with the vacuum relief valves in the lines that go to TEDF. Ms. Petersen added that the leaks are infrequent and would allow an exemption from notifying Ecology when a leak occurs. Mr. Bond suggested that RL/CHPRC notify him via phone call, even if notification would not be required.

C. LERF Basin Maintenance

Ms. Petersen reported that most of the cleanup on the Basin 42 cover has been done, with the exception of some mud in the four corners. Due to the spring bird migration, cleanup was moved to the Basin 44 cover. A large amount of water was pumped off the cover, and removal of the vegetation is under way. Ms. Petersen indicated that cleanup of the Basin 44 cover has been progressing very well. Ms. Petersen noted that the swallow activity started in the last few weeks, and bird deterrent actions are being taken. MSA has informed CHPRC that the bird deterrents are only effective for a period of time and then the birds start ignoring them. Mr. Farabee stated that the use of propane cannons as a bird deterrent was turned down by Hanford Patrol, and Bobby Long (RL) has been asked to interface with RL Security regarding the use of propane cannons. Mr. Farabee noted that the propane cannons worked fairly well for an extended period at FFTF. Ms. Petersen stated that she has not heard about the use of propane cannons, and that CHPRC is working with MSA regarding any options for bird deterrent.

D. Hanford Facility RCRA Permit Rev. 9 Update

Mr. Bond stated that a team headed by John Price (Ecology) is working on proposed changes to the content of Rev. 9, and the process may take two or three years. Mr. Bond added that the hazardous waste group out of Lacey, WA, believes that Rev. 9 should align with its hazardous waste permits.

E. 8C Class 2 Mods

Jennie Seaver (CHPRC) reported that a meeting was held with Mr. Bond, and agreement was reached regarding comment resolution. Ms. Seaver noted that the public comment period closes tomorrow (5/24/13). Mr. Bond stated that two sets of comments have been

received, and comment responses are being prepared. Ms. Seaver stated that a letter was received from Ecology regarding its position that Class 2 modifications will not require certification. Ms. Seaver added that RL/CHPRC are preparing a response to Ecology's letter by next week stating that previous Class 2 mod submittals will be certified. Ms. Seaver added that Andrea Prignano (Ecology) has indicated agreement with RL/CHPRC's response, but suggested that Mr. Bond touch base with Ms. Prignano to ensure she is still in agreement.

VI. Approved Changes Signed Off in Accordance with TPA Section 12.2

A. There were no approved changes identified for discussion.

VII. General Discussion

A. Mr. Bond initiated a discussion regarding an unreported new influent stream at ETF. Ms. Petersen responded that the ST-4500 permit requires approval from Ecology any time there is a new influent stream that is outside the accepted envelope. Ms. Petersen added that if the new influent stream is within the envelope, notification is made to Ecology via the Discharge Monitoring Report (DMR). Ms. Petersen noted that the DMRs used to be submitted as a hard copy, but the process has been upgraded to an electronic version. Ms. Petersen stated that the cover letter template for the hard copy version contained an alert to input new influent streams, but the electronic version is just a submittal of the certified DMR. Ms. Petersen indicated that the notification to Ecology was overlooked and not included in the electronic DMR, so notification was made about the 199B transfer pit wastewater shipments. Ms. Petersen noted that the shipments did not require Ecology approval. Mr. Bond asked about future notifications via the electronic version. Ms. Petersen responded that an internal system is being developed to ensure notification to Ecology is not missed in the future. Ms. Petersen added that the DMRs under the ST-4500 permit are not required to be submitted electronically yet, and issues with the electronic system are being worked.
