PROPOSED PLAN FOR REMEDIATION OF THE 300-FF-1, 300-FF-2, AND 300-FF-5 OPERABLE UNITS, DOE/RL-2011-47, REVISION 0; REMEDIAL INVESTIGATION/FEASIBILITY STUDY FOR THE 300-FF-1, 300-FF-2, AND 300-FF-5 OPERABLE UNITS, DOE/RL-2010-99, REVISION 0; AND REMEDIAL INVESTIGATION/FEASIBILITY STUDY FOR THE 300-FF-1, 300-FF-2, AND 300-FF-5 OPERABLE UNITS, ADDENDUM, DOE/RL-2010-99-ADD1, REVISION 0

This letter transmits the subject documents in compliance with Section 9.2 of the Hanford Federal Facility Agreement and Consent Order (Tri-Party Agreement). The Proposed Plan evaluates remedial alternatives and proposes a remedy for the 300-FF-01, 300-FF-02 and 300-FF-05 Operable Units under the Comprehensive Environmental Response, Compensation, and Liability Act. The Remedial Investigation/Feasibility Study and associated addendum provide information supporting the Proposed Plan.

These documents are "primary documents" as described in Section 9.2 of the Tri-Party Agreement. The Draft A Remedial Investigation/Feasibility Study and Proposed Plan were submitted to the U.S. Environmental Protection Agency (EPA) for review on December 27, 2011, (letter 12-AMCP-0042) in compliance with Tri-Party Agreement Target M-015-72-T01 and support of Tri-Party Agreement Milestones M-015-00 and M-015-00D. We worked closely with EPA over several months to incorporate resolution of comments, and the Remedial Investigation/Feasibility Study, Revision 0 was provided to EPA on November 8, 2012. This resulted in finalization of the Remedial Investigation/Feasibility Study and initiated preparation of a Remedial Investigation/Feasibility Study Addendum to incorporate the latest toxicity updates from EPA's Integrated Risk Information System and to evaluate a new remedial alternative


