I. Approval of September 24, 2009 CWC Project Meeting Minutes
 (Ecology/DOE-RL/CHPRC).

A. The PMM minutes were approved.

II. Operational Status

Paul Martin (M&EC) provided Michelle Mandis (Ecology) a new format for operational status that is being proposed. Mr. Martin noted that low flashpoint modules containing flammable waste are planned for disposition. Lori Fritz (CHPRC) stated that the modules are not contained in the Part A Permit, and RL/CHPRC proposed doing a partial closure plan for the modules.. The plan is to bring the waste out of the modules to CWC, and then dispose of the cabinets/storage modules at ERDF. Ms. Mandis asked why the modules were not included in the Part A, and if there was a treatment path planned. Ms. Fritz will provide information to Ecology regarding the status of other storage modules that are not currently included in the Part A and the proposed treatment path for the waste in the module.. Ms. Mandis noted the 9.95 cubic meters of waste shipped from Perma-Fix Northwest to CWC, and asked why it hadn't gone to the low level burial grounds yet. Ms. Fritz responded that oftentimes it's due to resource availability, and she will provide a response to Ecology.
