Re: Proposed Changes to the Tri-Party Agreement (TPA) for the Central Plateau Cleanup Work

The Washington State Department of Health Radioactive Air Emissions Section (RAES) has reviewed the information contained in the subject TPA change document. We are interested in this proposal because of the potential for radioactive air emissions and our statutory obligation to assess public impacts from Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) cleanup activities. My staff found the materials lacking in sufficient detail to determine the dose consequences of the decommissioning process for minor and major emission units currently licensed by the RAES.

In an effort to become informed, RAES requested a list of documents such as Engineering Evaluation/Cost Analysis' (EE/CAs), Removal Action Work Plans, or Action Memorandums. To date, RAES has not received any acknowledgement or response to our emailed request for a list of supporting documents and cannot make an informed decision.

At a minimum, we need to review the potential to emit, control technology selection, and compliance monitoring for each facility currently licensed by the RAES. In addition, we request that all licensed emission units transitioning to CERCLA follow the closure process outlined in the Air Operating Permit.
