



**TRI-PARTY AGREEMENT INTERIM MILESTONE TO PROVIDE A REMEDIAL
DESIGN/REMEDIAL ACTION WORK PLAN FOR 200-CW-5 AND 200-PW-1, 200-PW-3,
AND 200-PW-6 OPERABLE UNITS**
