The 600-305, Suspect Asbestos Containing Material Sites waste site is located in the 100-IU-2 Operable Unit of the Hanford Site and includes five areas in the Central Shops Area of White Bluffs, classified as five subsites, with suspect asbestos-containing material. The 600-305 subsites were identified as remaining sites for remediation in the *Explanation of Significant Differences for the 100 Area Remaining Sites Interim Remedial Action Record of Decision, Hanford Site, Benton County, Washington*, U.S. Environmental Protection Agency, Region 10, Seattle, Washington (EPA 2009). Remediation of the 600-305:1 and 600-305:2 subsites occurred on April 4, 2012, on May 14, 2012 for 600-305:3 and 600-305:4, and on May 15, 2012 for 600-305:5. The 600-305:1 and 305:2 remediation resulted in approximately 9 bank cubic meters (BCM) (12 bank cubic yards [BCY]) of material being removed and disposed, the 600-305:3 remediation consisted of the removal of a surface pipe presumed to contain asbestos material, and the 600-305:4 remediation resulted in approximately 2 BCM (2.6 BCY) being removed and disposed, and the 600-305:5 remediation resulted in approximately 20 BCM (26 BCY) being removed and disposed, all at the Environmental Restoration Disposal Facility (ERDF).

Cleanup verification sampling at the 600-305 subsites was performed on April 5, 2012 and May 21, 2012, to determine if the subsites meet remedial action objectives (RAOs) and remedial action goals (RAGs) established by the *Interim Action Record of Decision for the 100-BC-1, 100-BC-2, 100-DR-1, 100-DR-2, 100-FR-1, 100-FR-2, 100-HR-1, 100-HR-2, 100-KR-1, 100-KR-2, 100-IU-2, 100-IU-6, and 200-CW-3 Operable Units, Hanford Site, Benton County, Washington* (Remaining Sites ROD), U.S. Environmental Protection Agency, Region 10, Seattle, Washington (EPA 1999). The selected remedy involved (1) excavating the subsite to the extent required to meet specified soil cleanup levels, (2) disposing of contaminated excavation materials at ERDF at the 200 Area of the Hanford Site, (3) demonstrating through verification sampling that cleanup goals have been achieved, and (4) proposing the subsite for reclassification as Interim Closed Out.

Basis for reclassification:

Cleanup verification sampling results were evaluated in comparison to the RAGs. In accordance with this evaluation, the verification sampling results support a reclassification of the 600-305 subsites to Interim Closed Out. The current subsite conditions achieve the RAOs and RAGs established by the Remaining Sites ROD (EPA 1999). The results of verification sampling do not preclude any future uses (as bounded by the rural-residential scenario) and allow for unrestricted use of shallow zone soils (i.e., surface to 4.6 m [15 ft] deep). The analytical results and rationale presented in the attached remaining sites verification package also demonstrate that residual contaminant concentrations meet direct exposure cleanup criteria and are protective of groundwater and the Columbia River. The subsites' contamination does not extend into the deep zone soils. Institutional controls to prevent uncontrolled drilling or excavation into the deep zone soil are not required. The basis for reclassification is described in detail in the *Remaining Sites Verification Package for the 600-305, Suspect Asbestos Containing Material Sites; 600-308, Garnet Sand; 600-309, Burn Site #3; 600-310, Burn Site #4; 600-311, Burn Site #5; 600-312, Burn Site #6; 600-313, Burned Area and Oil Stained Soil; 600-314, Telecommunications Components; 600-317, Battery and Burn Area; 600-319, Miscellaneous Debris; and 600-324, Burnt Debris Area* (attached).




