1. Discuss any compliance questions/issues-

- o It was documented that J. Cammann (MSA) provided WDOE the requested photos of the WSCF Satellite Accumulation Areas in support of L. Fearon's recent Site visit. L. Fearon indicated there were no questions or concerns at this time.
