Description of Change:

Changes are proposed to revise the monitoring frequency for 241-T-201 and 241-TY-102 due to a detected intrusion and the change monitoring device on tank 241-BX-110 from a LOW to Enraf because liquid supernatant exists below the Enraf. Change form TPA-CN-621 (Administrative Record Accession #0085666) approved changes to RPP-9937 Revision 3C and created Revision 3D. This TPA change notice form modifies Revision 3D and creates Revision 3E.

 241-TY-102 (page 1-10): Change "Annual" to "Quarter," and "4.1.1.A.2" to "4.1.1.A.3."


RPP-9937 Table B-1 is revised as follows: 241-BX-110 (page B-x): Change "LOW used for intrusion only" to "Enraf used for intrusion only."

RPP-9937 Table 1-1 (page 1-6) is revised as follows: Delete duplicative row for 241-C-102 from Table 1-1. Delete row requiring quarterly leak detection monitoring (LDM) since tank is in retrieval status. Leave the annual best management practice (BMP) row in the table for future post retrieval monitoring.
