



This letter transmits the subject document in compliance with Section 9.2 of the Hanford Federal Facility Agreement and Consent Order (Tri-Party Agreement). The Remedial Investigation/Feasibility Study (RI/FS) presents results of RI/FS Workplan activities, conceptual site model, clean-up standards; and evaluates remedial alternatives for the 100-DR-1, 100-DR-2, 100-HR-1, 100-HR-2 and 100-HR-3, Operable Units under the Comprehensive Environmental Response, Compensation, and Liability Act.

The RI/FS is a primary document as described in Section 9.2 of the Tri-Party Agreement. The Draft A RI/FS and Proposed Plan were submitted to Ecology and the U.S. Environmental Protection Agency (EPA) for review on December 13, 2012, by letter 13-AMRP-0051, in compliance with Tri-Party Agreement Milestone M-015-00D. As described above, RL has worked closely with Ecology and EPA to incorporate comments and revise the documents.

The Proposed Plan will be submitted once Ecology and EPA legal reviews have been completed and resolution incorporated. As discussed with Nina Menard of Ecology, the public review process will proceed upon RL's submittal of the Proposed Plan to Ecology and EPA.
