





Dear Ms. Charboneau:

This letter transmits the Washington State Department of Ecology signature page for the Record of Decision (ROD) for the 100-FR-1, 100-FR-2, 100-FR-3, 100-IU-2, and 100-IU-6 Operable Units within the Hanford 100 Area NPL Site.

Ecology agrees with how Institutional Controls (ICs) and Monitored Natural Attenuation (MNA) are incorporated into this ROD for 100-F Area. Ecology bases its agreement on the site-specific circumstances at the 100-F Area.

This is the first of five RODs anticipated for the Hanford 100 Area soil and groundwater operable units (the remaining four addressing the 100-B/C, 100-D/H, 100-K, and 100-N Areas). As the lead regulatory agency for the next two RODs, which will address cleanup of the 100-D/H and 100-N Areas, Ecology will develop proposed remedies based on the site-specific circumstances of those areas.
