

In the References, the Washington State Department of Ecology identified two deficiencies that were observed during its inspection of waste generator activities at the U.S. Department of Energy, Material Handling Facility (MHF) on May 6, 2015. As noted in the References, Item 1 was corrected at the time of inspection and no further action is required. Item 2 in the References is associated with used oil container labeling and has been corrected since the inspection. The 10-gallon used oil container for draining filters has been replaced with a lidded container for proper closure as needed and it has been labeled "Used Oil" as demonstrated in the photograph in the Attachment. No further corrective actions are required and the Material Handling Facility is in compliance with WAC 173-303, *Dangerous Waste Regulations*, including WAC 173-303-630(3) for dangerous waste labeling and WAC 173-303-515(6) for used oil accumulation container labeling.




