Change Title: Delete M-15-21 milestone for preparing the IRM Proposed Plan for the 200-BP-5 Operable Unit, currently due on October 31, 1995.		
Description/Justification of Change The three parties agree that an IRM Proposed Plan is not required for the 200-BP-5 Operable Unit at this time. The treatability tests performed at the 200-BP-5 Operable Unit showed good results for removal of cesium, plutonium, technetium, and cobalt; and partial success for removal of strontium from extracted groundwater. However, aquifer conditions did not allow meaningful removal of contaminants from the aquifer to justify continuation of treatability test operations. Therefore, DOE requests that the interim Milestone (M-15-21) for submittal of an IRM Proposed Plan be deleted and contaminants at 200-BP-5 be addressed at a later time.		
Impact of Change Approval of the change request will remove the 200-BP-5 operable unit from the accelerated IRM pathway for groundwater cleanup. Further characterization/remediation activities will be planned at a later date following a Limited Field Investigation and/or Final Remedy Selection pathway.
