**U.S. DEPARTMENT OF ENERGY READING ROOM AND INFORMATION  
REPOSITORY INFORMATION DISTRIBUTION FOR THE  
HANFORD TANK WASTE REMEDIATION SYSTEM  
ENVIRONMENTAL IMPACT STATEMENT PROJECT**

The U.S. Department of Energy (DOE) Richland Operations Office (RL) and the Washington State Department of Ecology (Ecology) have agreed to co-prepare the Environmental Impact Statement (EIS) for the Hanford Tank Waste Remediation System (TWRS). The information provided to DOE Reading Rooms and Information Repositories shown in Table 1 is publicly available for review and copy.

DOE proposes to retrieve, pretreat, immobilize, and store or dispose of radioactive, chemical, and mixed waste currently or projected to be stored in 177 underground storage tanks, approximately 37 miscellaneous underground storage tanks (MUSTs) that are part of the waste transfer system, and 1,929 cesium and strontium capsules at, or being returned to the Hanford Site located near Richland, Washington. The TWRS EIS preparation schedule is shown in Table 2 and represents the current schedule as of March 30, 1995 (subject to change).

The proposed action is subject to the National Environmental Policy Act (NEPA) (42 U.S.C. 4321 et seq.) and the Washington State Environmental Policy Act (SEPA) (RCW 43.21C). Both acts require consideration of potential environmental impacts in the decision-making process. Ecology subsequently signed a Memorandum of Understanding (MOU) with DOE to jointly prepare the EIS for the proposed TWRS action.

In May 1989, the Hanford Federal Facility Agreement and Consent Order, also called the Tri-Party Agreement (TPA) was entered into with DOE, Ecology, and the U.S. Environmental Protection Agency (EPA) to govern waste management and cleanup of the Hanford Site. NEPA, SEPA, and the TPA are key regulatory requirements that must be considered during the preparation of these decision-documents. These, as well as other relevant laws and regulations are shown in Table 3.

NEPA establishes the requirements for preparing an EIS for major Federal action significantly affecting the quality of the human environment. The purpose of NEPA was to establish a national policy for the protection of the environment and it created the Council for Environmental Quality (CEQ). The CEQ regulations implementing NEPA are codified in 40 CFR 1500-1508. DOE's implementing procedures for NEPA are codified in 10 CFR Part 1021.

SEPA is intended to ensure that environmental values are considered by State and local government officials when making decisions. SEPA is very similar to NEPA in its intent and purpose. SEPA requires any Washington State agency proposing an action that might have a significant impact on the environment to evaluate all reasonable alternatives and their potential environmental impacts before taking action.


