

**Summary of Discussion and Commitments/Agreements****1. Approval of Past Unit Managers Meeting Minutes**

The April 13, 1995 Unit Manager Meeting minutes were approved.

**2. 325 HWTU Start-up Schedule**

Ms. K. Poston (PNL) stated that the operational readiness assessment was approved by the Operational Readiness Review Board on May 11, 1995. PNL is preparing a letter to submit to RL requesting concurrence to begin operations.

**3. 325 HWTU Part B Permit Application, Rev. 1**

- **New Submittal Date Letter**

Ms. Poston stated that a letter providing a new submittal date for the next version of the Part B is in the signature cycle. Certain portions of the text in the 325 HWTU Part B permit application will be relying on a generic document that WHC is drafting for the RCRA Hanford Facility Permit, and the first submittal of the generic document is due November 1995.

- **Ecology Informal Review and Comment**

Ms. J. Wallace (Ecology) stated that she is reviewing the contingency plan. Ms. Poston suggested that Ms. Wallace defer further review until the revised Part B permit application is available, and Ms. Wallace agreed.

- **Future Comment Resolution Workshops**

The comment resolution workshops have been postponed until the revised Part B permit application is completed. A schedule for the workshops is included in the letter providing a new submittal date for the Part B permit application. Mr. M. Cline (WHC) estimated that the workshops would commence in the January/February 1996 time frame.

**4. Status of 325 HWTUs NOI for Tank Storage**

Ms. Poston stated that WHC is preparing the notice of intent for PNL, and the Part B permit application will reflect the tank storage.

**5. Disposition of Old TK-1 Tank from Room 32 of SAL**

The TK-1 tank was placed in the 325 HWTU facility in the mid-1970s, and has been used for approximately 15 years to transfer low level, radioactive liquid waste from the Shielded Analytical Laboratory hot cells to the 340 collection basins via the radioactive liquid waste system. The tank was taken out of service immediately following a leak 2 - 3 years ago, and a new tank has been installed. The TK-1 tank was disconnected and moved to an isolated portion of Room 32. The empty tank was placed in a containment pan.

Mr. R. Steel (PNL) proposed treating the TK-1 Tank as radioactive mixed waste and sending it to the Central Waste Complex (CWC). The analytical documentation and records of the material contained in the tank would be provided to CWC. Ms. Wallace conferred approval to proceed. Ms. Wallace inquired about removal of the tank. Mr. Steele responded that removal of the tank remains to be negotiated with WHC; however, he speculated the tank would be
