

WHC (D. M. Korematsu-Olund) stated that work continues on preparing the Data Evaluation Report on the sampling analytical results. WHC (D. M. Korematsu-Olund) asked if Ecology had reviewed the analytical results from the soil sample splits that Ecology took. Ecology (F. Ma) stated that the review, by their chemist, of the data results indicated that there was no contamination present at the Ash Pit site.

WHC (D. M. Korematsu-Olund) stated that agreement on the permit conditions for modification A of the Hanford Site Facility Permit was completed on April 24, 1995. Ecology (F. Ma) agreed that Ecology responded to all the comments submitted on the permit conditions.

WHC (D. M. Korematsu-Olund) proposed that the UMM meeting be held every other month because issues pertaining to the demolition sites were essentially completed. Ecology (F.
