

**- Status of Page Changes for Revision 1a**

ZC Knaus reported that comments from a DOE/RL and Westinghouse were to be submitted to him by COB March 6, 1995. He will require two weeks to incorporate these changes. Around the first of April the document will begin the transmittal process to meet the April 15, 1995, deadline for submittal into the Hanford Facility Permit.

**-Status of Sampling and Analysis Plan**

ZC Knaus state that the Sampling and Analysis Plan will be completed shortly after submittal of the 105-DR Closure Plan into the permit. This will ensure the SAP reflects the current changes being made to the closure plan.

ZC Knaus will provide Ecology (SE Mckinney) with a current copy of the AR for 105-DR to review and make sure all necessary references are contained within the Administrative Record.
