

Summary of Discussion and Commitments/Agreements

1. Approval of Past UMM Minutes

The October 18, 1994, Unit Managers' Meeting Minutes were reviewed and signed by the Unit Managers.

3. Status Closure Activities:

-Status NOD Comments (On Schedule)

WHC (D. M. Korematsu-Olund) stated that RL transmitted the validated data to Ecology on November 15, 1994. Ecology (F. Ma) affirmed that Ecology had received the validated data and that the Ecology chemist is currently reviewing the sample data. WHC (D. M. Korematsu) stated that a draft copy of the closure plan page changes has been sent to Ecology and inquired if Ecology was satisfied with these changes for both 200 West Area Ash Pit Demolition Site (Ash Pit) and 218 E-8 Borrow Pit Demolition Site (218 E-8). Ecology (F. Ma) stated that everything in the closure plans looked okay with the page changes included. Ecology would proceed in including the two demolition sites into the Site-Wide Facility Permit Modification. Ecology (F. Ma) stated that there would not be any further changes from Ecology and that a formal letter confirming Ecology's satisfaction with the closure plans will be issued.

Ecology (F. Ma) wished to reiterate for the record that Ecology had requested that a sentence be added to section 6.3.2 of both closure plans, stating that if any hits (contamination levels above Hanford Site-Wide Background or MTCA Method B Levels) were found in the initial sampling, a phase two investigation would be developed during a subsequent DQO negotiation process with all parties involved. WHC (D. M. Korematsu-Olund) stated those changes have been made to both closure plans. And as soon as RL receives a formal letter from Ecology stating its acceptance of the two closure plans, the page changes will be distributed.

**4. New business:**

WHC (R. K. Bhatia) introduced Joseph J. Waring as the new RL-Operations Unit Manager, replacing Edward D. Macalister.

**5. Set new meeting date:**
