#### Summary of Discussion and Commitments/Agreements

##### Approval of Past Unit Managers Meeting Minutes

The August 10, 1993 Unit Manager Meeting minutes were approved and signed.

##### Closure Plan Revision Status

Mr. W. Slater (PNL) stated that PNL had received comments from RL regarding the Simulated High Level Waste Slurry (SHLWS) closure plan. Mr. Slater indicated that approximately half of the comments were related to the sampling analysis plan, which will be impacted by the Data Quality Objective (DQO) process that the parties are scheduled to begin January 25, 1994. The comments that PNL concurred on are being incorporated into the SHLWS closure plan. PNL has scheduled a meeting with MACTEC on January 26, 1994, to resolve the remaining comments.

##### DQO Process Status for Sampling and Analysis Plan

Ms. G. Davis (Ecology) inquired about the status of the sampling portion of the sampling analysis plan. Mr. C. Lindenmeier (PNL) indicated that the sampling portion will be redone. Since the original sampling plan was written, there have been modifications in the Washington Administrative Code (WAC) and incorporation of the Hanford sitewide background studies for background determination levels, which will drive a different approach to writing the sampling plan. Mr. Lindenmeier stated that PNL plans to follow WHC's closure plan format wherever possible, and to use the DQO process to provide the details for SHLWS's specific operation.

As noted above, under the topic of Closure Plan Revision Status, the DQO process will begin January 25, 1994.

##### Separate EPA/State Identification Number

Mr. R. Krekel (RL) stated that Form 2 containing the proposed separate ID numbers for contiguous properties at the Hanford Site is in concurrence at RL, and a copy will be transmitted to Ecology when it is issued. Mr. Slater noted that a decision regarding the separate ID numbers would probably not be made before the SHLWS closure plan approval process begins, and he questioned the impact on the closure plan. Ms. Davis stated that it would affect closures

that occur under the current ID number. Ms. Davis added that she had just received a revised SHLWS Part A permit application, and the permit reflected that the SHLWS was located in the 1100 Area. Mr. Slater responded that the Part A permit application had been submitted some time ago, and Mr. Krekel added that Form 3 will be revised whether or not a separate ID number is established.

Mr. B. Day (PNL) inquired about Ecology's reorganization. Ms. Davis indicated that she would remain the unit manager for SHLWS. Mr. Day provided a copy of the SHLWS closure plan to Ms. Davis.
