Summary of Discussion and Commitments/Agreements

1. Approval of Past UMM Minutes

The May, July and August and September Unit Managers' Meeting Minutes were signed. There was not a June or October Unit Managers' Meeting.

2. Status Closure Activities

- Closure Plan Review by Ecology

Ecology (Mr. S.E. McKinney) informally transmitted a Notice of Deficiency (NOD) List. The draft copy of the list is attached. Mr. McKinney indicated that a Revision 1A of the 105-DR Large Sodium Fire Facility (105-DR LSFF) Closure Plan should be prepared based on these NOD's.

- Revision of Closure Plan

In response to the NOD's, Ecology (Mr. S.E. McKinney), DOE (Mr. R.N. Krekel) and WHC (Mr. F.A. Ruck III) agreed to make several changes to the closure plan. An expanded section describing the events between partial clean closure of 105-DR LSFF and final Decontamination and Decommissioning of the 105-DR Reactor will be inserted into the closure plan via page changes. Additionally, the sampling plan will be modified to provide authoritative sampling and more sampling locations.

Attendees also discussed calculation of cleanup standards. Mr. F.A. Ruck III suggested that a comparison table should be produced to determine the effect of each calculation method. The table will contain cleanup standards calculated by The Model Toxics Control Act (WAC 173-340) (MTCA) and The Hanford Site Baseline Risk Assessment Methodology (DOE/RL-91-45, Revision 1) (HSBRAM).

3. New Business

Action Item:

- 11-17-93:1 Prepare a table comparing cleanup standards for 105-DR LSFF. Calculate concentrations using both the MTCA and HSBRAM methodologies.

4. Set Next Meeting Date

The next meeting was scheduled for Wednesday, December 15, 1993. The meeting is planned to be a video teleconference between Richland and Lacey, Washington.
