The July 20, 1994, Unit Managers' Meeting Minutes were reviewed and signed by the Unit Managers.

-Status NOD Comments (On Schedule)

WHC (D. M. Korematsu-Olund) that WHC Commercial Analytical Services has not received the analytical results for the July 13, 1994 sampling effort. WHC (F. A. Ruck III) stated that WHC would inform Ecology on the progress of the laboratory analysis.

WHC (D. M. Korematsu-Olund) stated that the draft 200 West Area Ash Pit Demolition Site (Ash Pit) and the 218 E-8 Borrow Pit Demolition Site (218 E-8) closure plans revision 1 were sent out for concurrent RL and WHC review on August 11, 1994. Ecology received a copy of both draft closure plan revisions on August 11, 1994. WHC review comments for both closure plans are due back on August 25, 1994. RL and Ecology review comments on the draft Ash Pit closure plan revision 1 is due August 25, 1994 and 218 E-8 review comments are due back to WHC by September 1, 1994.

Ecology (F. Ma) inquired why a letter from RL requesting a 15 day extension was sent to someone else at Ecology instead of him. WHC (F. A. Ruck III) stated that with Ecology's reorganization the letter was mistakenly sent to the wrong person. WHC (D. M. Korematsu-Olund) asked if Ecology was going to grant RL request for the 15 day extension to the 218 E-8 closure plan revision 1 submittal date. Ecology (F. Ma) agreed with RL request and would send a letter accepting the extension request..
