Re: Notice of Deficiency number for the 200 Area Effluent Treatment Facility

On May 26, 1994, the Washington State Department of Ecology (Ecology) issued a group of Notice of Deficiency (NOD) comments on the Part B Permit Application for the 200 Area Effluent Treatment Facility (ETF). NOD comment number 58 addressed the issue of Land Disposal Restrictions (LDR) and stated that "this section will be reviewed by the EPA and any comments will be sent at a later date." Since these NODs have been issued, it has been agreed upon between the U.S. Department of Energy, its contractors, and Ecology that the Part B Permit Applications for the ETF will be combined with those for the 200 Area 242-A Evaporator and the Liquid Effluent Retention Facility. Since LDR issues will change substantially for the combined permit, it is not necessary to respond to comment number 58 at this time. Any LDR issues which solely affect the ETF can be raised at the NOD workshops scheduled to begin in February.
