Dear Mr. Rasmussen:

The Washington State Department of Ecology (Ecology) has reviewed the 2101-M Closure Plan, Revision 2 and determined that it is complete. Our staff compared the revised closure plan with the 2101-M Pond Notice of Deficiency Response Table dated March 5, 1993, and determined that the closure plan was revised in accordance with the commitments that were accepted in the response table. Therefore, preparations for public review of the closure plan should be planned for inclusion in the first Modification to the Facility Wide Permit, which is planned for January 1995.

Ecology agrees with the findings of the Phase II sampling, that there are no dangerous wastes or waste constituents present in the pond soils above regulatory concern. Hence, the pond is considered to meet the requirements for clean closure making the contingent "closure/postclosure plan" section of the 2101-M Pond Closure Plan unnecessary. However, it may remain in the closure plan for completeness.


