Summary of Discussion

Jim Bellomy (WHC) stated that they are continuing to make progress on a response to Ecology's NOD's concerning the Part B permit application. The gist of this meeting was clarifying several points about NOD's.

In response to Ecology's concern about the fact that information concerning the rail cars in the tunnels was dated January, 1990, WHC will update this information to make it current as of January 1, 1991. Essentially no change in the status of these cars has occurred. The permit application will also state that the status of these rail cars will be updated in WHC's annual report for the PUREX storage tunnels.

Language in Chapter 11, associating the movement of rail cars with closure, will be changed. The movement of rail cars will no longer be covered as part of closure activities and will not appear in Chapter 11. Rail car movement activities will become part of operations and will be addressed in Chapter 4.

Language in Chapter 11, concerning the conduct of radiation surveys well in advance of the tunnels closure, will be changed. Again this language will be removed from Chapter 11. This section will be revised to state that radiation surveys will be done as needed to remove rail cars from the tunnels. This will also be contained in Chapter 4.

Concerning the language about professional engineering certification, Megan Lerchen (Ecology) stated that this statement should be of a boiler plate variety which is common throughout all the permit applications. The actual language will be worked out in site wide meetings.

Closure plan estimates will be included in the annual report. The content of these estimates and the submittal dates will be decided in the site wide meetings. The actual language/format of these closure estimates will be established by DOE for inclusion in the permit application. Cliff Clark (DOE) stated that the initial estimates for closure costs may be provided in a letter and followed up in the required annual report.

Megan Lerchen (Ecology) stated that the proposed changes to the spill reporting requirements for dangerous wastes are still open for comment. These requirements are being addressed in the site wide meetings. Topics to be addressed in these discussions include the various types of records which need to be kept at the facility and how long they will be kept.
