My staff has reviewed the Notice of Construction (NOC) for the 105N Basin Stabilization Project. It was complete and professionally well prepared. Approval for this project is granted, pending a final determination of monitoring requirements by the Environmental Protection Agency under 40 CFR 61.

Please note that all applicable standards must be adhered to. It is understood that this approval is to stabilize the 105N Basin in a radiologically and environmentally safe condition so that it can be decommissioned at a later date. It is also understood that the abated emissions projected EDE to the offsite MEI is no greater than 0.0002 mrem/year. Approved activities and conditions are limited to those discussed in the NOC.
