Summary of Discussion and Commitments/Agreements

1. Approval of Past UMM Minutes

The January 13, 1994 Unit Managers' Meeting (UMM) minutes were approved and signed by the RL Unit Manager (R. N. Krekel). The Ecology Unit Manager (R. E. Cordts) verbally approved the minutes and will sign at a later date.

2. Status Prior Action Items:

- 5-04-93:1 WHC and RL will submit a petition requesting approval of the sonification procedure for the determination of volatile organics in concrete by following the guidelines in WAC 173-303-110(5).

WHC (A. L. Prignano) reported that the sonification petition is still going through the review process with the RL support contractor. RL and WHC do not yet have an estimate on the date the procedure will be submitted to Ecology.

RL (R. N. Krekel) questioned Ecology (R. E. Cordts) on who within Ecology will be reviewing the petition; Would the petition stay within the Nuclear and Mixed Waste organization, or will it go to an outside organization? Ecology (R. E. Cordts) responded that Ecology is going to depend heavily on the EPA Manchester Laboratory for review and opinion on the procedure. Megan Lerchen, of Ecology, may get involved; however, she is very busy at the moment and may not have time. WHC (A. L. Prignano) added that the WHC chemists have been holding discussions with Dr. Steven Pope of the EPA Manchester Laboratory. The chemists most recently met with Dr. Pope about a week ago.

3. Status Closure Activities

- HASM will complete data validation of soil samples by March 11, 1994.

WHC (A. L. Prignano) stated that validation of the results of the soil sampling at the 300 ASE should be completed by mid-March. This sampling event took place in August 1993. In response to a question from Ecology, WHC (A. L. Prignano) added that an initial review of the results showed that they looked good when compared to site-wide background and health based standards.
