Summary of Discussion

From Ecology's preliminary review of the Notice of Deficiency response table, it appears that the main issues are related to issues of closure strategy rather than sample plan-related issues.

A question which still needs to be answered is how reactor decommission and demolition (D and D) activities will mesh with RCRA or CERCLA activities. In WHC's view, the biggest problem in this question is the timing and coordination of activities related to when can work begin and to what extent a building will be D and D'd before a decision is made on the type of closure used. Of particular interest to Ecology is how the reactor D and D activities will mesh with RCRA and CERCLA, and no decision on this will be made until the environmental impact statement (EIS) is released. Firm dates on when the EIS will be released are not available.

It was noted that the stack will be included as part of the ventilation system by Ecology. Ecology will give careful consideration as to how various components of the unit are to be divided up under regulatory authority since these decisions in this unit will likely be precedent setting.

Ecology expects to have comments on the closure plan prior to the next Unit Managers meeting.

The next 105-DR UMM is expected to take place Tuesday, March 3, 1992 in Richland, Washington.
