Summary of Discussion and Commitments/Agreements

1. Approval of Past UMM Minutes

The August 11, 1993, Unit Managers' Meeting (UMM) minutes were confirmed and signed by the Unit Managers and other officials that were present. This was a teleconference between RL and its contractors in Richland, and Ecology (R. E. Cordts) in Lacey. Mr. Cordts verbally approved the minutes and stated that he would sign them at the October UMM.

2. Status Prior Action Items:

- 5-04-93:1 WHC and RL will submit a petition requesting approval of the sonification procedure for the determination of volatile organics in concrete by following the guidelines in WAC 173-303-110(5).

WHC (F. A. Ruck III) stated that WHC has incorporated RL's comments on the sonification procedure. RL will transmit the procedure to Ecology in late September. In the first quarter of FY94, upon approval of the procedure by Ecology, WHC will begin the concrete sampling activities around the 300 Solvent Evaporator.

3. Status Closure Activities

- Status Sonification Procedure

This item was addressed in item 2.

4. New Business

Ecology (B. Cordts) asked if the concrete sampling activities are weather dependent. WHC (F. A. Ruck III) stated that cooler temperatures would be beneficial for sampling the organics. The main weather related concern will be brushing away snow cover during the sampling activities. WHC will check with sampling personnel to determine the weather dependence of the sampling activities and respond to Ecology.

5. Set Next Meeting Date

The next meeting was set for October 13, 1993, at 10:00 a.m. in Richland, Washington.
