Z PLANT SOURCE AGGREGATE AREA MANAGEMENT STUDY REPORT (AAMSR) DRAFT B REDLINED
VERSION SHOWING COMMENT DISPOSITIONS

This letter transmits the redlined version Draft B of the Z Plant Source AAMSR, showing the dispositions to review comments provided by the State of Washington Department of Ecology (Ecology), and the U.S. Environmental Protection Agency (EPA) on Draft A of the Z Plant AAMSR (M-27-03).

This revision includes the following (in addition to your specific comments in the EPA letter to A. C. Harris from D. Faulk "Review of Z Plant Source Aggregate Area Management Study [AAMS] Draft A" dated April 13, 1992):

- Finalized generic text based on Z, S, and T AAMSRs regulator comments
- Section 2.3.2 text regarding Single Shell Tanks with repetitive material reduced
- A generic physical model in Section 4.0
- Implementation of the analogous site concept in Section 9.0
- Minor changes as a result of Westinghouse Hanford Company technical editing

As agreed to at the July 1992 Unit Managers' Meeting, you will have a two-week review period beginning August 24, 1992, followed by a meeting to discuss any comments tentatively scheduled for September 8, 1992.


