The U.S. Environmental Protection Agency (EPA) has not received official transmittal of the revised Sampling and Analysis of 100 Area Springs report (DOE/RL-92-12) from the U.S. Department of Energy (DOE). This report was printed and submitted to DOE by Westinghouse Hanford Company in mid-May, but has not been transmitted by DOE to the regulators.

EPA provided comments to DOE on the first printing of the M-30-01 report (letter to Steve Wisness, dated April 2). In this letter, EPA stated that the report "falls short of both the intent and letter of the milestone" and that "EPA does not consider this milestone completed". We believe the revised report will complete the milestone. EPA awaits transmittal of this report in order for DOE to complete this milestone.
