

Ecology (J. J. Wallace) received the Notice of Deficiency (NOD) Response Table from RL on June 30, 1993. The NOD response table comments from Ecology are due to RL, September 28, 1993. However, since Ecology has assigned a new unit manager to the 218 E-8 Closure Plan, the response date maybe delayed.

4. New business:

-Data Quality Objectives

A seminar illustrating the Data Quality Objectives (DQO) process, using the 200 West Area Ash Pit Demolition Site and the Hexone Storage and Treatment Facility has been proposed for August 25-26, 1993. RL (R. N. Krekel) stated that they would like to have as many people from Ecology there to observe or to participate as possible in this DQO process. Ecology (J. J. Wallace) stated she has a time conflict and asked that the seminar be rescheduled. RL (R. N. Krekel) stated that the schedule will be reviewed and notification of the meeting details will be forthcoming.

Ecology (J. J. Wallace) stated that Ecology RCRA Permit Section has just hired a new unit manager (Fenggang Ma) who will be taking over all three of the demolition sites (Ash Pit, 218 E-8, and HPADS). Ecology (J. J. Wallace) stated that she didn't know if the new unit manager could complete the review of the NOD response tables by the end of September, therefore some additional shuffling of schedules may occur.
