Summary of Discussion

Prior Meeting Minutes

The meeting opened at 9:23 AM with the distribution of the prior meeting minutes. Mr. Witczak indicated that he had only recently (June 16, 1992) received the past meeting minutes and had not as yet had time to read them. While reading the past meeting minutes at the current meeting for possible on-the-spot approval, he noticed verbiage regarding the use of CLP protocols for 2727-S sampling. He felt this verbiage required consideration beyond a cursory review and so the past meeting minutes were not signed as being approved by Ecology.

Status of 2727-S Closure Plan Comments

The next topic of discussion concerned the approval status of Revision 3 of the closure plan which is currently at Ecology for comments. WHC asked if Ecology comments were available. Mr. Witczak responded that he had not as yet read Revision 3 but would make it a priority upon his return to the main office.

New Business

Item 1. Use of sitewide soil background study information in lieu of performing 2727-S site background sampling

WHC asked Ecology if background levels established by the Hanford site-wide soil background study could be used in lieu of taking 3 background samples at the 2727-S perimeter fence as required by the closure plan. Ecology stated that this may be acceptable if both Ecology and the EPA approve the site-wide soil background findings before 2727-S background sampling begins. WHC indicated that EPA had reviewed the site-wide soil background study with minimal comments and if Ecology's comments were of the same nature the document might be approved by the sampling date. Mr. Witczak indicated that he was not certain that Ecology will accept the site-wide soil background study as the sole source for all site-wide background information and that there may still have to be some, although minimal, confirmatory sampling.

Item 2. Elimination of XRF screening if background sampling is deleted

WHC stated that if use of the site-wide soil background study levels is acceptable in lieu of background sampling, that the associated XRF field screening at these locations could also be eliminated. The XRF is generally only being used where its results can be compared to lab analyses and so is of minimal value without lab analyzed background samples for comparison.
