224-T TRANSURANIC WASTE STORAGE AND ASSAY FACILITY DANGEROUS WASTE PERMIT APPLICATION (HANFORD FEDERAL FACILITY AGREEMENT AND CONSENT ORDER, GROUP NUMBER S-2-2, MILESTONE NUMBER M-20-23)

With this letter the Department of Energy, Richland Field Office (RL) is returning the 224-T Transuranic Waste Storage and Assay Facility (224-T TRUSAF) Dangerous Waste Part B Permit Application (Part B) copies that were inadvertently sent back to us. This Part B application document was originally submitted on June 30, 1992, to satisfy TPA Milestone M-20-23. It was properly certified prior to submittal and is still the correct revision of the Part B application for 224-T TRUSAF. After submittal of the 224-T TRUSAF Part B, it was determined that a revised Dangerous Waste Part A Permit Application (Part A) for the 224-T TRUSAF was necessary.

While the revised Part A was going through the RL concurrence and certification process, an RL clerk, who was unfamiliar with the certification process, unknowingly sent an uncertified copy of the 224-T TRUSAF Part A to the State of Washington Department of Ecology (Ecology) on September 2, 1992. As soon as the error was discovered, RL called Ecology to request that the document be returned so that it could be properly certified. There apparently has been some confusion on the part of Ecology over which document was requested to be returned to RL since we have not received the errant Part A but did receive Ecology's copies of the 224-T TRUSAF Part B.

This letter returns the Part B permit application copies to Ecology. To avoid further confusion, RL has prepared another copy of the revised Part A application. A certified copy of the revised Part A for the 224-T TRUSAF will be sent as soon as it has been properly certified.


