

Summary of Discussion and Commitments/Agreements

1. Status of NOD cycle:

During the February 17, 1993, Hexone closure plan Unit Manager Meeting discussion (held in conjunction with this Unit Manager Meeting) Ecology (J.J. Wallace) stated that the Notice of Deficiency (NODs) for all four closure plans (Hexone, Ash Pit, 218 E-8, and HPADS) will be issued to RL in accordance with the Tri-Party Agreement review and comment process flowchart (March 1, 1993). However, Ecology (M.A. Selby) stated that additional NODs maybe issued at a later date.

RL (R.N. Krekel) requested that instead of having four closure plans and their subsequent NOD responses due on the same day, that the due dates be staggered to alleviate administrative burden. Ecology (J.J. Wallace and M.A. Selby) approved of this idea. WHC (F.A. Ruck) will prepare a staggered schedule for the four closure plan's response cycle by the next UMM (Action 2-17-93:1). Once agreed by the Unit Managers, the schedule will be issued formally by RL to EPA and Ecology.

2. Discuss new business:

Ecology (J.J. Wallace) requested that a separate meeting be set up to discuss current analytical lab procedures, along with questions about the proposed use of a mobile laboratory for chemical analysis of RCRA samples. RL (R.N. Krekel) agreed that a separate meeting to discuss lab procedures would be scheduled and the date was set for March 31, 1993. An agenda for the March 31, 1993 meeting will be set up by WHC (F.A. Ruck) (Action 2-17-93:3) once Ecology (J.J. Wallace) provides a draft agenda and a list of concerns (Action 2-17-93:2).

Ecology (L.E. Russell) requested a list of the people in charge of closure plans. RL (R.N. Krekel) stated that R.G. McLeod and himself were the RL Unit Managers representing RCRA closures and therefore the only official contact personnel. RL issued a letter to EPA and Ecology in January 1993 providing an updated list of RCRA closure plan Unit Managers for RL. However, for technical questions specific to a closure plan, a list of WHC lead personnel would be prepared by WHC (F.A. Ruck) to be provided to Ecology (Action 2-17-93:4).

3. Set new meeting date:

The next Unit Managers Meeting is scheduled for March 17, 1993, in Richland Washington.
