Summary of Discussion and Commitments/Agreements

1. Approval of Past UMM Minutes.

Final meeting minutes for the April 6, 1993 UMM and the May 4, 1993 UMM were signed as approved by the unit managers.

2. Status of Action Items

3. Status Closure Activities
- Data Evaluation Report

WHC (Mr. S. N. Luke) indicated that RCRA Closures is still evaluating 2727-S laboratory data in order to prepare a final data evaluation report that will address contamination found above detection levels at the site. Regarding preparation of the data evaluation report: the Sampling Report, which will be a portion of the final report, is being reworked by Environmental Engineering; RCRA Closures is awaiting Integrated Risk Information System (IRIS) database information for certain constituents to assist with identifying appropriate cleanup levels; and, a report from the laboratory for inorganics results for sample B07555 is expected after laboratory error was identified in the original analysis.

Ecology (Mr. R. E. Cordts) inquired about an expected arrival date for the B07555 inorganics lab report. WHC (Mr. S. N. Luke) indicated that RCRA Closures had been unable to obtain an estimated arrival date for the report but would pursue expediting lab response.

- Requirements for Oil Spill Removal Area

Ecology (Mr. R. E. Cordts) acknowledged that he had received a compilation of information, FAXed by WHC, pertaining to a minor spill of an oil-like substance that occurred during site demolition. WHC (Mr. S. N. Luke) indicated that the same information had been distributed to Ecology (Mr. J. J. Witczak), RL (Mr. R. N. Krekel) and to WHC (Mr. F. A. Ruck, and others) at the time of the spill. However, because the occurrence was prior to the tenure of Mr. Cordts as the 2727-S Ecology unit manager, this spill information had been forwarded to him in order to assist Ecology in making a final determination regarding the need for any further sampling of the spill removal area. It is the WHC/RL

position that the information provided to Ecology constitutes sufficient basis (i.e., small quantity of spilled material; total containment and removal; and, characterization of the removed soil, via the waste designation process for sample B07562, as nondangerous waste) for Ecology to reasonably conclude that further soil sampling of the spill removal area is not necessary. Resolution of this issue will be an agenda item for the next UMM.

- Marking of Barrels Containing Nonregulated Waste Soil

Ecology was informed that the barrels located at the 2727-S site containing waste soils had been labeled as containing nonregulated waste soils based on recent characterization of these soils by Solid Waste Engineering as nondangerous waste. RL, WHC and Ecology agreed that the final disposition of the soil is yet to be determined.
