-Revision of Closure Plan

The extension letter has been received by Ecology. They will be sending a letter agreeing to the extension. Ecology stated that the revised Closure Plan should retain Closure Plan as the title, not Closure/Postclosure Plan.

New Business

Ecology stated that after the limited closure of the LSFF is completed, the Part A application will be revised to only include the exhaust tunnels, 117-DR Building (filter building), and exhaust stack. This will ensure that RCRA-regulated wastes in the 105-DR Building will be recognized when D&D activities begin.
