

# HANFORD 1100 AREA (DOE)

## Public Health Assessment

**WHAT:** Make plans now to read and comment on the public health assessment for the *Hanford 1100 Area (DOE)*. The *Agency for Toxic Substances and Disease Registry (ATSDR)*, part of the U.S. Public Health Service, has looked into possible health effects from environmental contamination at the 1100 Area and evaluated these in the public health assessment. This public health assessment addresses only the 1100 Area and not the other Hanford Superfund sites (the 100, 200, and 300 Areas).

**WHY:** *Your Opinion is Important!* ATSDR wants to know if you think the public health assessment addresses your health concerns. Your comments will be addressed in the final report. Although the report will not list your name, names and comments will be subject to Freedom of Information Act requests. Therefore, you should use your own judgment about personal information in your comments. Only written comments will be accepted. If enough comments are received, a public meeting may be held.

**WHEN:** The 45-day public comment period will run from July 18, 1995 to September 1, 1995. Comments postmarked after that time will not be considered for revision of the document.
