Justification of Change. After consulting with DOE in the context of M-34 negotiations, EPA and Ecology have decided to employ Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA) as the regulatory process for K Basins cleanup. This change of Lead Regulatory Agency will maintain consistency with the approach to regulatory authority and Lead Regulatory Agency designation as agreed to in the Sixth Amendment of the Agreement and Section 5 of the Agreement Action Plan. Under paragraph 88 of the Agreement EPA and Ecology have joint authority to determine the choice of Lead Regulatory Agency and regulatory process in consultation with DOE.																											
In addition to the change specified above the Parties recognize the continuing areas of Ecology involvement and/or authority. Examples include Ecology's regulatory authority, as specified in Section 5.6 of the Agreement Action Plan, over Treatment, Storage and/or Disposal units such as the 1706-KE Treatment Facility (116-KE6 A-D) closure. Additionally, Ecology shall remain involved in matters where K Basin activities affect or impact other areas in which Ecology is the Lead Regulatory Agency. These related activities could include the handling of K Basin sludge, water, and secondary wastes.																											
Impact of Change No impact is expected as a result of this change in Lead Regulatory Agency designation other than assignment of appropriate resources within the EPA to effectively deal with the Lead Regulatory Agency responsibilities associated with oversight of the K Basins cleanup.
