#### **Summary of Discussion and Commitments/Agreements**

##### **1. Approval of Past PMM Minutes**

The June 4, 1998 minutes have been approved and issued. The May 7, 1998 and August 6, 1998 minutes are ready for approval.

##### **3. Status Closure Activities**

###### **- Reports and Certifications**

The 303-K closure activity report for FY 1998, including the Professional Engineer (PE) certification for the closure activities, has been transmitted to Ecology.

###### **- Uranium Issue**

RL (E. M. Mattlin) stated that the uranium issue will be raised to upper management for resolution. At issue is Ecology's request for cleanup of the uranium in the soil at 303-K, and DOE-RL/Headquarter's position that Ecology does not have regulatory authority over uranium. DOE is proposing cleanup of the uranium when the entire 300 Area is cleaned up under CERCLA. Ecology (J. J. Wallace) added that Ecology's position is to allow the physical remediation of the uranium with the CERCLA operable unit, but that the 303-K Part A will remain in effect and the facility would still be considered a RCRA TSD.

###### **- Building Demolition**

BWHC (J. A. Remaize) reported that demolition of the 303-K building is scheduled for FY 2001; however, BWHC is seeking funding to perform the demolition as early as FY 1999
