

**100-D PONDS SURVEY PLAT, NOTICE IN DEED, AND CERTIFICATION OF RECORDING**

To fulfill the requirements of Washington Administration Code (WAC) 173-303-610(9) and 173-303-610(10), the U.S. Department of Energy, Richland Operations Office, is hereby transmitting the 100-D Ponds Survey Plat (Attachment 1). Also included in this transmittal is a copy of the notice in deed (Attachment 2). The survey plat and notice in deed have been recorded with the Benton County Auditor as noted in the attached certification of recording (Attachment 3), required by WAC 173-303-610(10).

In accordance with the requirements of the WAC 173-303-610(9) and 173-303-610(10) the survey plat and notice in deed describe real property in which dangerous wastes had been previously disposed. The WAC 173-303-610(9) and 173-303-610(10) also require recording the type, location, and quantity of dangerous wastes disposed to the facility and any land use restrictions associated with the property. This information is recorded on the survey plat as follows:

“The property described above, known as the 100-D Ponds, was used to manage dangerous waste pursuant to WAC 173-303. The Department of Energy, Richland Operations Office, closed this facility by removal of dangerous waste constituents from the site during closure activities, meeting “clean closure” standards under WAC 173-303-610 (2)(b). Groundwater contamination attributable to sources upgradient of the 100-D Ponds, remains beneath the 100-D Ponds above cleanup standards at the time of preparation of this record of survey. Therefore, use of this groundwater is restricted until such time as cleanup standards are met or it has been determined that cleanup is not necessary.”





## CERTIFICATION




