



- I. Approval of the January 22, 2004 PURGEWATER Project Meeting Minutes Ecology/DOE-RL/FH)
- II. Operational Status (John Winterhalder FH)
 - Total PW received in February was 82,614 gallons. Total PW received in December and January was 23,029 and 60,769 gallons, respectively. The total for December was significantly greater than that for November due to recent aquifer testing and well development associated with a busy winter new well installation schedule.
