The U.S. Department of Energy (DOE), Office of River Protection (ORP), is in receipt of the State of Washington Department of Ecology (Ecology) letter dated May 16, 2001 (Reference 2). This letter disapproves DOE Change Requests M-45-01-01, M-62-01-02, and M-90-01-01, all dated May 2, 2001. On May 21, 2001, we resubmitted the M-45-01-02, M-90-01-02 and M-62-01-03 (Reference 1) change requests with additional information identified in your disapproval letter, asking Ecology to reconsider their disapproval. Ecology again disapproved our request.

As a result, pursuant to Article VIII Resolution of Disputes, paragraph 30 of the Tri-Party Agreement, ORP objects to Ecology's disapproval and is by this letter, initiating Dispute Resolution. ORP will make reasonable efforts to informally resolve this dispute with Ecology within 30 days at the project manager level.
