



NEXT STEPS FOR THE 224-T PLUTONIUM CONCENTRATION FACILITY

The Tri-Party Agreement (TPA) Agencies want your feedback on a draft Engineering Evaluation/Cost Analysis (EE/CA) for Hanford's 224-T Plutonium Concentration Facility located in the Central Plateau on the Hanford Site.

For eleven years, the 224-T Facility served as a chemical processing facility that supported the plutonium recovery process done at T Plant. After being idle for several years, the facility was modified in 1975 to store plutonium-bearing wastes. In 1985 a portion of the facility was operated as a permitted Resource Conservation and Recovery Act (RCRA) treatment, storage and disposal facility.

The draft 224-T EE/CA evaluates alternatives on what to do with the facility. The alternatives range from leaving the facility in place (no action) to decontamination and demolition of the entire structure and underlying foundation. The preferred alternative is to tear down the above-ground structure and leave the foundation and underlying soil in place awaiting future cleanup decisions for that area.

The agencies will begin a 45-day public comment period that will run from January 12 through February 26, 2004.
