DESIGNATION OF REMEDIAL PROJECT MANAGERS (RPMs) AND ON-SCENE
COORDINATORS (OSCs) FOR REMOVAL AND REMEDIAL ACTIONS CONDUCTED
UNDER THE COMPREHENSIVE ENVIRONMENTAL RESPONSE, COMPENSATION
AND LIABILITY ACT (CERCLA) AT THE HANFORD SITE

DOE is sending this correspondence to notify you of the designation of Matthew S. McCormick as RPM and OSC for all CERCLA removal and remedial actions performed in the 200 Area on Hanford's Central Plateau (200 Area National Priorities List [NPL] site and sitewide Groundwater); of David A. Brockman as RPM and OSC for all CERCLA removal and remedial actions for the K Basins; and of Joe R. Franco Jr. as RPM and OSC for all CERCLA removal and remedial actions along Hanford's Columbia River Corridor (100, 300, and 1100 Area NPL sites, Fast Flux Test Facility and Environmental Restoration Disposal Facility).

These designations have been made pursuant to the requirements of 40 CFR 300.120 which direct that the lead agency (DOE) shall assign RPMs to manage remedial and other response actions at NPL sites.

The DOE OSC/RPM may, at his discretion, delegate all or portions of these responsibilities and authorities to other DOE staff, including but not limited to, DOE operable unit, treatment, storage, or disposal group/unit or milestone project managers or to DOE sub-project managers or task managers. Such delegations will be subject to the limits of project manager duties, roles and responsibilities as described in 40 CFR 300.120.


