### DRAFT B PLANT AGGREGATE AREA MANAGEMENT STUDY REPORT (AAMSR)

The Hanford Federal Facility Agreement and Consent Order interim milestone M-27-07 requires that an AAMSR for the B Plant be submitted to the U.S. Environmental Protection Agency and the State of Washington Department of Ecology by June 30, 1992. This AAMSR was developed as a secondary document in accordance with the objectives and format for the AAMSR presented in AAMSR Chapter 1, which was submitted as interim milestone M-27-01. It represents the sixth of ten reports that will be prepared as part of the 200 Areas National Priority List AAMS Program.

The U.S. Department of Energy, Richland Field Office (RL) comments are currently being dispositioned and have not been completely incorporated into the text of this document; consequently, RL may require changes to the draft.

Please note that generic text, which has previously undergone regulatory review, has been highlighted by vertical bars in the text. Shading in the Table of Contents indicates those sections containing generic text. The highlighted text is currently being finalized based on regulatory comments received on the U and Z plants AAMSRs and will be incorporated into the final B Plant AAMSR. Therefore, we appreciate that regulatory review of the B Plant AAMSR is limited to the B Plant Aggregate Area specific text.

Also enclosed is a copy of the Geological/Geophysics Data Package for the B Plant Aggregate Area.


