SUBMITTAL OF THE 304 CONCRETION FACILITY CLOSURE PLAN, REVISION 2 (TS-3-2) 32892

The U.S. Department of Energy, Richland Operations Office (RL) and the Westinghouse Hanford Company (WHC) are submitting the 304 Concretion Facility Closure Plan, Revision 2 to the U.S. Environmental Protection Agency (EPA) and the State of Washington Department of Ecology (Ecology). Submittal of this revised closure plan fulfills the November 30, 1993, commitment date. The Notice of Deficiency (NOD) Response Table is included with the closure plan.

The closure plan has been revised to incorporate the changes discussed at the Unit Managers Meetings between late-1992 and mid-1993. Implementation of these changes was requested by the Ecology letter of July 28, 1993, (S. E. McKinney, Ecology, to R. N. Krekel, RL, "Revision of the 304 Concretion Facility and 303-K Radioactive Mixed Waste Storage Facility Closure Plans (M-20-13 and M-20-15)"). The primary change in the closure plan is to address the site-wide soil clean-up standards. The closure plan has also undergone a general revision to update the document format to the current standards.


