DRAFT A, Z PLANT AGGREGATE AREA MANAGEMENT STUDY REPORT (AAMSR)

This letter transmits the Draft A, Z Plant AAMSR for review and comment by the U.S. Environmental Protection Agency and State of Washington Department of Ecology. The report fulfills Hanford Federal Facility Agreement and Consent Order interim milestone M-27-03 for submittal of this AAMSR as a secondary document.

The report was prepared as a secondary document in accordance with the objectives of the Hanford Past Practices Strategy (HPPS) (DOE/RL-91-04) and the methodology and format for the AAMSR presented in AAMSR Chapter 1, which was submitted as interim milestone M-27-01. It represents the second of 10 reports that will be prepared as part of the 200 National Priority List Aggregate Area Management Study (AAMS) Program.

The 200 AAMS data evaluation process flowchart (Figure 9.1 in the enclosed report) has been revised to include HPPS Expedited Response Action criteria in the data evaluation process. In addition, the flowchart was simplified to contain only those decision boxes used to develop the recommendations provided in the report (i.e., secondary or follow-on decisions have been deleted). Lines have been added to denote text that is generic to all AAMSRs.

The U.S. Department of Energy, Richland Field Office (RL) comments are currently being dispositioned and have not been completely incorporated into the text of this document. As a result, RL may require changes to the draft.


